The Role of MSMEs in the Context of the Clean Energy Transition in MENA The Lebanon Case Study

In 2019, Lebanon entered into one of the worst economic and financial crises in modern history, leading to the near collapse of public services. The energy and power sector were among the most severely impacted, affecting micro, small, and medium enterprises (MSMEs) in particular. As the cost of diesel-powered private generators skyrocketed, many enterprises resorted to solar energy. Despite the severity of the crisis, it provided an opportunity for some businesses to adapt, grow, and even thrive, most prominently renewable energy suppliers and agrifood businesses.

The Lebanese Center for Policy Studies (LCPS), in collaboration with the Economic Research Forum (ERF) and the Middle East Institute (MEI), and with the support of the International Development Research Center (IDRC), embarked on a project that seeks to deepen our understanding of the energy challenges and opportunities facing MSMEs in six MENA countries (Egypt, Jordan, Lebanon, Morocco, Tunisia, and Sudan) as they attempt to transition to a low-carbon economy.

In this conference, LCPS will present its yearlong case study of the state of the energy transition at the level of MSMEs in Lebanon. The case study is based on data collected between October 2023 and July 2024, reflecting the MSME landscape and stakeholder perspectives at that time. The information presented, as well as the proposed recommendations, do not fully reflect the impact of recent conflict-related destruction and displacement.

Invited speakers will examine ways the public sector, donors, and international organizations can support MSMEs in the context of the energy transition. Other issues that will be discussed include the macroeconomic reforms necessary to encourage the adoption of renewable energy by the private sector and how Lebanon can scale up support for distributed clean energy and energy- efficient solutions.
